

TAILGATE WEEKENDS SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. SEE ALTERNATIVE METHOD OF ENTRY BELOW FOR ADDITIONAL WAYS TO ENTER WITHOUT OBLIGATION.

ELIGIBILITY: The TAILGATE WEEKENDS SWEEPSTAKES ("Sweepstakes") is open to all legal US residents who are 18 years of age or older as of date of entry and who are members of—or are eligible for membership at—Four Points Federal Credit Union. A full list of member eligibility requirements and select employer groups can be viewed online at <https://www.fourpointscfu.org/connect/membership>. Void outside the USA, in Puerto Rico, the US Virgin Islands, and other United States territories and possessions. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations, and is void where prohibited by law.

Board of Director Members, Supervisory Committee Members, Educational Services Committee Members, and Employees of Four Points FCU and their immediate family members are not eligible to enter this Sweepstakes. Immediate family is limited to the spouse, parents, stepparents, foster parents, father-in-law, mother-in-law, children, stepchildren, foster children, sons-in-law, daughters-in-law, grandparents, grandchildren, brothers, sisters, brothers-in-law, sisters-in-law, aunts, uncles, nieces, nephews, and first cousins.

Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. If a potential winner is also a Four Points FCU member, the member and all accounts owned by the member must be in good standing, as determined by Sponsor, to claim their prize.

SPONSORSHIP: The Sweepstakes sponsor is Four Points Federal Credit Union/Four Points FCU/FPFCU ("Sponsor"), located at 510 North 127th Street, Omaha, Nebraska, 68154. <https://www.fourpointscfu.org>. Sponsor will conduct the Sweepstakes substantially as described in these Official Rules.

ENTRY PERIOD: This Sweepstakes begins on 9/9/2023 at 12:00 AM CST/CDT and ends on 10/14/2023 at 11:59 PM CST/CDT ("Entry Period").

HOW TO ENTER: Fill out an entry form physically at any Four Points FCU branch location—Dodge or West Center.

Bonus entries can also be earned by completing the following tasks:

- 1) Participate and/or win football-themed games (bag or football toss)
 - a. Limited to one gameplay per eligible person during the Entry Period
 - i. One (1) entry for participating, plus additional based on performance (highest score/entry amount will be honored, not cumulative):
 1. Two (2) entries for throwing a football in the small target holes OR landing a beanbag in the box hole
 2. One (1) entry for making larger holes OR landing bags on the box

- 2) Donate items during the credit union food drive which runs concurrently with the Entry Period
 - a. There is no limit to total entries earned by eligible donations
 - i. One (1) entry earned per three (3) canned or boxed food items
 - ii. One (1) entry earned per pack of water bottles (24pk or greater)

- 3) Open a new credit union account at any Four Points FCU branch location—Dodge or West Center
 - a. There is no limit to total entries earned by opening new, legitimate accounts
 - i. Five (5) entries earned by opening any account as a new member with no prior Four Points FCU relationship
 - ii. Five (5) entries earned by opening a Purchase Rewards or Premier Checking Account
 - iii. Five (5) entries earned by opening a Term Certificate (Regular, Stash Your Cash, or Choice)
 - iv. Five (5) entries earned by booking a Loan (Auto, Personal, Mortgage, Home Equity)

ALTERNATIVE ENTRY: To enter without obligation—hand print your name, street address, city, state, zip code, phone number, e-mail address, and the words "**Tailgate Weekends Sweepstakes**" on a 3"x5" card and mail it in an envelope to: **Four Points Federal Credit Union, ATTN: Marketing Department, PO BOX 541030, Omaha, NE, 68154.**

All entries must be individually handwritten and mailed separately. If an entry form is incomplete or illegible, that entry form will be disqualified. Handwritten entries received become the property of the Sponsor and will not be returned.

LIMITATIONS ON ENTRIES: There is no limit to the number of entries a participant may earn during the Entry Period, whether through the initial entry form, earned bonus entries, or handwritten alternative entries.

Any person who attempts or otherwise encourages the use of false contact information under multiple identities; or uses any circumventive device or artifice to enter; or submits false entries—as determined by the Sponsor—will be disqualified.
