Four Points Federal Credit Union - Election of Officers

The election of Board Member will take place at Four Points Federal Credit Union.

Although Directors serve on a volunteer basis, their work is extremely important to the overall operation of the Credit Union. With this in mind, you are encouraged to nominate members who are absolutely committed to the work of maintaining a first-rate Credit Union.

Only voting Credit Union members are eligible to participate in this election, either as nominees, or as the term implies, voters. **Voting members are defined as individuals having accounts with Four Points Federal Credit Union, and for joint accounts, the first person listed on the account is considered the voting member.**

Those members wishing to be placed on the ballot who have not been selected to run by the Credit Union’s nominating committee must submit petitions, signed by at least 72 Four Points Federal Credit Union members and return the petitions to the Credit Union office by the close of business on Friday, December 14, 2018. Nominations by petition must be accompanied by a signed Statement of Intent from the nominee or nominees stating that they are agreeable to nomination and will serve if elected to office. Petition forms are available online at www.fourpointsfcu.org and at the Credit Union office. Signatures (names) and other information on the petition will be checked to ensure validity. Members must be at least 18 years of age to sign the petition and vote.

There are two methods for submitting nominations by petition:

1. Single nomination forms completed by voting members individually and forwarded back to the Credit Union by mail or email by the closing petition date.
2. Obtaining the required number of voting member signatures and information on a Petition for Nomination form and submitting the list of required petition signatures to the Credit Union by mail or email by the closing petition date.

The Closing petition date for the 2019 Board Elections is close of business Friday, December 14, 2018.

There will be no nominations from the floor when the number of nominees equals the number of positions to be filled.
